2. Authorize the Mayor, Richard A. Moccia to execute a 5 year lease agreement with Tryone Martylewski for the Caretakers Cottage Cranbury Park. Terms 5 years 5% each year increase:

6. Approve the use of Rowayton Elementary School grounds by Rowayton Civic Association for their Annual Rowayton Nativity Pageant to be held Saturday, December 18, 2010 from 6:00 PM – 8:00 PM. Estimated attendance 100+.
