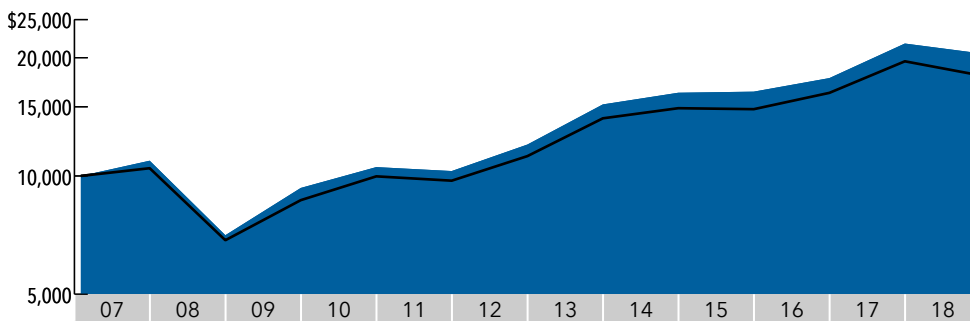

S&P Target Date Through 2045: S&P Target Date Through 2045 Index, a subset of the S&P Target Date 2045 Index, has an asset allocation and glide path that aim to be more sensitive to longevity risk at, and beyond, the retirement date.
