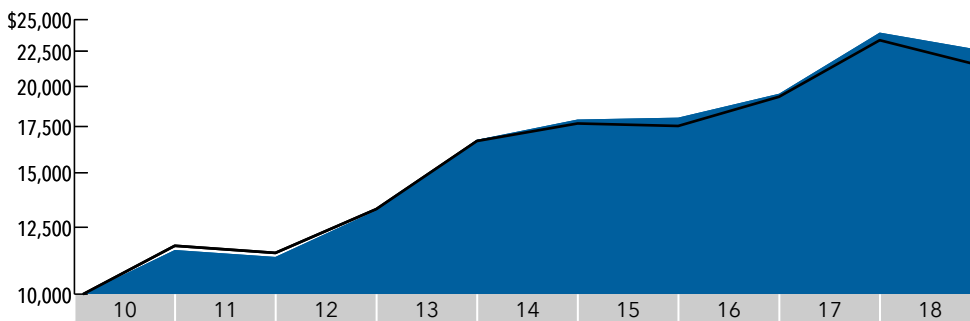

S&P Target Date Through 2055: The S&P Target Date Through 2055 Index, a subset of the S&P Target Date 2055 Index, has an asset allocation and glide path that aim to be more sensitive to longevity risk at, and beyond, the retirement date. The index is fully investable, with varying levels of exposure to the asset classes determined during an annual survey process of target date funds' holdings.
