As stated in the Norwalk Code Public Works Related Ordinances, Chapter 94, Section 8: **LICENSE REQUIRED TO COLLECT AND/ OR TRANSPORT SOLID WASTE:**

The Director shall be the licensing and registration authority for all solid waste collectors, vehicles and refuse containers operating within the City. It shall be unlawful for any person to collect or remove solid waste in the City or to transport the same upon or through any street or public place of the City has been granted a license by the Director to do so.

- Solid Waste License & Vehicle Registration Form (this form)
- Application for Solid Waste Commercial Permit (Blue Form): COMPLETED & SIGNED with Tare Weights Certified by City Weighmaster
- Vehicle Registration: Provide a **copy** of ALL vehicle registrations clearly showing each vehicle license plate information
- Vehicle Insurance: Provide a **copy** of the certificate of insurance for EVERY vehicle with endorsement naming the “City of Norwalk” as additional insured
- Connecticut Department of Energy & Environmental Protection’s Annual Solid Waste Reporting Form: Reporting period July 1, 2020 to June 30, 2021 is due at time of application; all others are past due
- Past Due Fees: **The Commercial Account will be placed in a “NO DUMP” Status and will NOT have access to City Facilities until all past due Amounts have been PAID IN FULL.**
